John Childs, City Engineer, presented the bids received for the 2018 Pipe, Fittings and Accessories, and Hydrants and recommended award to low bidder on each schedule. Schedule A for Water Pipe had 5 bids received and low bid was Northwest Pipe Fittings for \$45,996.40, Schedule B for Fittings and Accessories he 5 bids and low bid was Core & Main (formerly HD Supply) for \$46,319.05, Schedule C for Hydrants had 2 bids and low bid was Core & Main for \$27,078.84. Commissioner Mehlhaff moved and Commissioner Huizenga seconded to award bid for Schedule A Pipe to Northwest Pipe for \$45,996.40, Schedule B Fittings & Accessories to Core and Main for \$46,319.05, and Schedule C Hydrants to Core and Main for \$27,078.84. Unanimous approval.

Lindy Garrets requested the renewal of the 2018 Lease Agreement for the Capital City Farmer's Market at the City Parking Lot at the corner of Sioux Avenue and Coteau. This is the 8th year at this location and it's been successful for the market and the downtown businesses. Commissioner Johnson moved and

Commissioner Barringer seconded to approve the 2018 lease agreement with Capital City Farmer's Market as presented. Unanimous approval.

Tiffany Sanderson presented a request to hold the first annual inaugural Run with the Gov's on June 16<sup>th</sup>. She has reviewed the route with City staff, Police Department, and SD Department of Transportation. They will begin at the front of the Capital building and pass by most all of the Governor's statues and wraps up with a loop in Hilger's Gulch and ends at the Capital Building. It's a 4 mile run/walk that is designed to be a fundraiser for future governor statues. Commissioner Huizenga moved and Commissioner Johnson seconded to approve the 2018 Run with the Gov's route as presented. Unanimous approval.

John Childs, City Engineer, presented a request to purchase a 2018 Chevrolet Impala off the SD State Bid contract. The vehicle will replace an older impala in the City's fleet. Commissioner Barringer moved and Commissioner Mehlhaff seconded to approve the purchase of 2018 Chevrolet Impala as presented. Unanimous approval.

John Childs, City Engineer, presented the request to bid the 2018 street paving project. The bid package includes 41 blocks of mill and overlay and 16 blocks of rebuild. The program stretches the City's dollars by taking advantage of different technology. Commissioner Barringer moved and Commissioner Johnson seconded to approve the request to bid 2018 street paving project as presented. Unanimous approval.

Brad Palmer, Utilities Director, introduced the Consultants from AE2S that completed a comprehensive study of the City's water system. The study was a result of community feedback regarding the City's water. The City's water quality meets all regulatory standards for safety drinking water. The Study results in a report that recommends that the City pursue a Water Treatment Plant to be located in Steamboat Park at an estimated cost of \$35 million, at a cost to the Water customers of approximately \$1/day. Mayor Harding explained that there will be 3 meeting scheduled the next few months to allow the community to ask questions and gain a better understanding of the report results and recommendations. Commissioner Mehlhaff moved and Commissioner Huizenga seconded to put the decision to build a water treatment plant on the June ballot. Unanimous approval.

Commissioner Johnson moved and Commissioner Mehlhaff seconded to adjourn at 7:18pm. Unanimous approval.
