**Staff Reports**

**Carin Hayn, PGA professional, clubhouse manager**—We had just over 32,000 rounds play. This was one of our best seasons to date so people were out playing which is great. We had \$94,764 more in revenue this year then we did last year. I had to present to the City Commission and told them all of these numbers, but we are obviously a weather-driven industry. We will be hosting both the girls and boys ESD tournaments next year. We are hosting SDGA's two-woman tournament as well.

**Bryan Tipton, CGCS Superintendent**

Since our last meeting, we finished the aerification. We are starting to see the benefits of this when you are riding the aerifier. It feels different when you are riding the equipment on the fairways vs. not on the fairways. We had a summer that was very hot and sometimes golf courses will enforce cart path traffic only and fortunately we didn't have to do that. We are working on cleaning out the cart barns this week. When we blow out the irrigations when we close it was at 30% moisture. We were looking last week, and it was down to about 15% but that was due to the high winds we had. We decided to go ahead and water those last week. We are apart of that winter study with the university. There are 8 sensors in the greens and we made it about 10 days before the coyotes chewed through one of the wires. We had a great Fall and we were able to get a lot of work done. Bartlett- Are you going to be doing any tree removal?

Tipton- We got the inmates back recently so we are hoping to clear out some of the wetlands. We try to cut down the dead trees because the birds like to go in there and they move all of the weed seed.

**Tom Farnsworth, Director**

This was Tom's last meeting as he will retire the end of January. Tom was happy that the board was happy with the course. We have great customer service and the golfing community was pleased with the overall product and how the course played. The board thanked Tom for his service and wished him well in his retirement plans.
