**Section 11-2-101 Adoption of National Electrical Code and the rules and regulations of the South**

**Dakota Electrical Commission.**

There is hereby adopted the most current version of the electrical code known as the *National Electrical Code*, as adopted and administered by the South Dakota Electrical Commission and subject to the rules and regulations of said commission and the whole thereof, except such portions as have been deleted, modified or amended and filed in the Finance Officer's office, for the purpose of governing the construction, alteration, materials and appliances used in connection with electrical work and the operation of all electrical apparatus within the city. Additional deletions, modifications and amendments may from time to time be made by the City commission and shall be effective upon their adoption and filing with the Finance Officer. The Finance Officer shall keep and maintain a master copy of said code, including all deletions, modifications or amendments which may be adopted by the City Commission as herein provided and the same shall be available as herein provided and the same shall be available and subject to public inspection at all reasonable times.

**Section 3.** That Ordinance No. 1265 of City of Pierre entitled Section 1, Adoption of the National Electrical Code, and all other ordinances or parts of ordinances in conflict herewith are hereby repealed.

**Section 4.** That if any section, subsection, sentence, clause or phrase of this ordinance is, for any reason, held to be unconstitutional, such decision shall not affect the validity of the remaining portions of this ordinance.

**Section 5.** That nothing in this ordinance or in the Electrical Code hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in Section 3 of this ordinance; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this ordinance.

**Section 6.** That the Finance Officer is hereby ordered and directed to cause this ordinance to be published.

**Section 7.** That this ordinance and the rules, regulations, provisions, requirements, orders and matters established and adopted hereby shall take effect and be in full force and effect twenty (20) days from and after the date of adoption and publication.
